### What information do we collect? How do we use it?

When you use our website, register for wedding fairs, download the wedding guide or sign up for the engagement email we may collect, derive, combine, assess, or otherwise process your personal information for the following purposes:

1. The monitoring of customer traffic patterns and website usage to help us to develop the design and layout of the website.
2. Notifying you of High Times Weddings Limited news and information, which we think, may be of interest to you including by email, mail, phone, SMS or other electronic means where you have granted us permission to do so.
3. Offering, administering and providing products and services.
4. Providing you with a more personalised user experience when using our website or any other services we might provide to you by analysing, segmenting and profiling our database and allowing us to target you with information we think you might be most interested in including products and services.
5. Sending you surveys for quality management purposes.
6. Generating wedding fair registration lists including quantifying the number of potential attendees
7. To share with the wedding prize draw supplier (see terms and conditions for details of whom the current prize draw supplier).

8. To select and contact a prize draw winner for the purposes of arranging fulfilment of the prize draw prize.
9. In the event we sell or buy any business or assets, in which case we might disclose your personal data to the prospective buyer or seller.
10. If we are under a legal duty to disclose or share your personal data in order to comply with or meet any legal obligation.

### **Legal basis for processing your data**

We undertake the activities above for the reasons below:

- In the pursuit of our legitimate interests as a commercial organisation including the marketing and promotion of our brand, products, and services.

### **What we do with the information that we collect?**

We will never use your information in a way incompatible with this privacy notice. This will include amongst others that:

- We will not put any information about you on general release
- We will not transfer personal data outside of the European Economic Area.

### **Your consent**

By using our website, registering for our wedding fairs or signing up to our newsletter, you consent to the use of any information provided by you, collected from you, or derived based on collected personal information by High Times Weddings Limited for the purposes described in this privacy notice. ### **Retention**

We collect personal information for specific purposes and on specific legal bases and endeavour to collect only the personal information required for those purposes. Once this purpose has been fulfilled and the personal information is no longer required, we will anonymise your data by removing any identifiable information or erasing it.

### **Your rights**

When requesting access to your personal data provide as much detail as possible about what personal data you would like access to and include in the subject line that it regards an access request. If you so choose you may request us to rectify, erase or block the processing of your personal data if that personal data is no longer accurate, up-to-date or when the further processing of that personal data would be in violation of applicable data protection legislation.
